**3. A. BEARINGS ARE MEASURED CLOCKWISE FROM 000° (TRUE NORTH) TO 359°. THE BEARINGS OF THE LIGHTS ARE GIVEN SEAWARD.**

**B. AREA COORDINATES ARE GIVEN COUNTER CLOCKWISE FROM LOWER LEFT CORNER EXCEPT THE AREA ADJACENT TO THE SHORELINE.**

**4. TEMPORARY NOTICES TO MARINERS AND PRELIMINARY NOTICES TO MARINERS ARE INDICATED WITH (T) AND (P), RESPECTIVELY, BEFORE THE PARAGRAPH.**

**5. MARINERS ARE REQUESTED TO INFORM ONHO WITH THE HYDROGRAPHIC MEMORANDUM AT THE END OF THIS BULLETIN (\*\*) IN CASE OF ANY INFORMATION RELEVANT TO SAFETY OF NAVIGATION.**
